






#### VALUE OF HIGHER EDUCATION

Higher education focuses on the holistic and transformative development of individuals, going beyond specialized job training. A college education equips students with critical thinking, communication, and problem-solving skills applicable across various professions, fostering adaptable and well-informed citizens who contribute to a vibrant democracy. While job readiness is crucial, a narrow focus on immediate employment overlooks the long-term benefits of a liberal arts education. Higher education graduates, with their interdisciplinary background, are well-positioned to contribute fresh ideas and perspectives, which is vital for addressing complex challenges. We ask Congress to consider the wide-ranging benefits of higher education in addition to the financial benefits. Please resist legislation and push back on regulations that see higher education primarily through an economic lens.



# CHARITABLE GIVING DECLINED IN 2022 AND IS EXPECTED TO FURTHER DECLINE.

Giving to religious organizations is expected to decline more because religious giving is predominated by individuals, and giving by individuals declined by 6.8%, or 13.4% when adjusted for inflation.


## **CHARITABLE GIVING**

#### The CCCU supports charitable giving at all levels for all individuals.

For every \$1 in federal grant money a student receives, CCCU institutions provide \$5 in institutional financial aid, and a significant percentage of that crucial institutional aid comes from charitable donations. We encourage support for the bipartisan Charitable Act (H.R. 3435, S. 566) which would restore and expand the universal charitable giving deduction.

- of donors provide **88%** of charitable giving. We want to increase this to ensure lower to middle income and younger donors have an incentive to give.
- Current deduction only available to those who itemize.

We are grateful for many parts of the new FAFSA, including that the new form will be simpler and shorter. However, we ask you to support reintroducing the consideration of siblings in college into the financial aid formula. This commonsense factor greatly affects the ability of families and students to afford college.

## **MENTAL HEALTH**

55%

Over half of current college students (55%) who have considered leaving college cite emotional stress as the primary driver, according to a recent national survey.

- Fighting for the rights of religion, association, and speech, which ensure CCCU institutions can teach as well as maintain policies that are consistent with their religious beliefs and convictions while participating fully within the public square.
- Ensuring that institutions adhering to biblical principles are protected in areas such as federal funding, hiring, Title IX, and free speech.
- Advocating for legislation, regulations, and judicial rulings that protect religious freedom for individuals and institutions of faith.
- Working with a broad coalition of religious traditions and denominations to support principled pluralism.

- Protects the unity of the immediate family;
- Respects the rule of law;
- Guarantees secure national borders;
- Ensures fairness to taxpayers; and
- Establishes a path toward legal status and/or citizenship for those who qualify and who wish to become permanent
