



Author, Journalist & Staff Writer for The Atlantic

Tim Alberta is an award-winning journalist, best-selling author, and staff writer for The Atlantic magazine. He formerly served as chief political correspondent for POLITICO. In 2019, he published the critically acclaimed book, "American Carnage: On the Front Lines of the Republican Civil War and the Rise of President Trump" and comoderated the year's final Democratic presidential debate aired by PBS Newshour. Tim joined The Atlantic in March 2021 with a mandate to keep roaming and writing and telling stories that strike at the heart of America's discontent. His work has been featured in dozens of other publications nationwide, including Sports Illustrated and Vanity Fair, and he frequently appears as a commentator on television programs

in the United States and around the world. His newest book, "The Kingdom, The Power, and The Glory: American Evangelicals in an Age of Extremism," explores the timely, rigorously reported, and deeply personal examination of the divisions that threaten to destroy the American evangelical movement. Tim lives in southeast Michigan with his wife, three sons, and German Shepherd.



**CURTIS CHANG** 

Founder, Redeeming Babel

Curtis Chang consults with nonprofits and government agencies and teaches at public, private, and Christian universities. He also leads Redeeming Babel, a nonprofit bringing theological clarity to vexing cultural issues, and has partnered with CCCU schools to help students navigate two crucial issues: mental health and politics. His most recent project, The After Party, promotes a Christ-centered political identity to combat toxic polarization through a six-session online course and book releasing from Zondervan in April 2024. Curtis is a former senior pastor and author of several books including "The Anxiety Opportunity: How Worry Is the Doorway to Your Best Self."



#### DR. SHERILYN R. EMBERTON

President, Huntington

Dr. Sherilyn R. Emberton serves as the 13th president of Huntington University.

Prior to accepting the presidency at Huntington in 2013, Dr. Emberton served as the provost and vice president for academic affairs at East Texas Baptist University in Marshall, Texas, and in that same role at Lincoln Memorial University in Harrogate, Tennessee. Dr. Emberton began her career in private higher education at LeTourneau University in Longview, Texas, as the associate vice president for academic affairs.

She completed a Doctor of Education degree in 1999 from Texas A&M University-Commerce and both a Bachelor of Science in education

degree and a Master of Education degree from Stephen F. Austin State University.

Dr. Emberton chairs the executive board of Northeast Indiana Regional Partnership and sits on the Northeast Indiana Chamber of Commerce board of directors. She is the director of higher education for the US National Conference and the United Brethren Church in Christ, and she chairs the Lenawee Christian Ministries Board in Adrian, Michigan.

Dr. Emberton joined the board of directors of the Community Harvest Food Bank of Northeast Indiana in 2015 and the board of directors for Indiana's AgriNovus and Elevate Ventures Northeast Indiana in 2017. In 2019, Dr. Emberton was elected to the board of directors for the National Association of Independent Colleges and Universities (NAICU) and asked to serve on the Executive Board of Indiana Agrinovus. In 2020, Dr. Emberton was elected to serve on the Executive Committee of NAICU and the Governing Board of the Council for Christian Colleges & Universities (CCCU).



**SCOTT HAWLEY, Ph.D.**Professor of Physics, Belmont University

Scott H. Hawley was thrust into considering the impacts of AI on education in 2013, upon seeing a demo of a machine-learning (ML) based audio source-separation app that he knew would change the lives of his students at Belmont University. His academic works include numerous technical works integrating AI with music and audio production, industry collaborations receiving the Les Paul Music Innovation Award from Gibson USA, and winning the Incubator Lab contest from Art+Logic. He worked as a technical fellow in generative AI "unicorn" company Stability AI's audio group Harmonai, helping to build the system that was released as

Stable Audio in July of 2023. Hawley became involved in AI ethics in 2017 as part of the "Bridging the Two Cultures of Science and Religion II" program run by Scholarship and Christianity in Oxford (SCIO), writing essays, a book chapter, and reviews that have appeared in "Perspectives on Science and Christian Faith," and winning the 2021 FaithTech Writing Contest. He is a founding member of AI and Faith, and speaks and writes regularly on matters of AI, ethics, science, and religion. He is active on social media platforms under the name @drscotthawley.



SHIRLEY HOOGSTRA
President, CCCU

Shirley Hoogstra became the seventh president of the CCCU in September 2014. In this role, Hoogstra combines her zeal for the rule of law and her passion for Christian higher education as she promotes the value and purpose of high quality, Christ-centered liberal arts education that shapes students who love the Lord with all their heart, soul, and mind. Prior to the Council for Christian Colleges & Universities, Hoogstra served for 15 years as vice president for student life at her alma mater, Calvin University, and spent more than a decade practicing law as a partner at a firm specializing in litigation in New Haven, Connecticut.

Michael J. Paulus, Jr., is dean of the library, assistant provost for educational technology, and associate professor of information studies at Seattle Pacific University. Dr. John Farquhar Plake is a researcher with a pastor's heart. He bridges the worlds of social science, business intelligence, and spiritual formation, helping Christian leaders understand how people grow in Christ. Dr. Plake serves as chief ministry officer at American Bible Society and is the editor-in-chief of the annual State of the Bible research study. Over 33 years of full-time ministry, John has served as a nonprofit leader, pastor, missionary, professor, and researcher.

He is an ordained minister with a Ph.D. in intercultural studies. He lives with his family in Wilmington, Delaware.



### REV. DR. ANGULUS DION WILSON, Ph.D., D.MIN.

Chaplain, Fresno Pacific University

Rev. Dr. Angulus Dion Wilson, Ph.D., D.Min., is a dedicated servant of Christ with a profound calling to guide students in their personal relationship with Jesus. With three decades of experience in both national and international ministry, Dr. Wilson's passion for ministry has led him to establish congregations throughout North America.

As a university chaplain and church planter, he has made significant contributions to the Christian community. Dr. Wilson's academic journey is equally impressive, with a bachelor's degree in social work from Fresno Pacific University, master's degrees in spiritual formation leadership and evangelism from Wheaton College and Birmingham Theological Seminary, and doctorate degrees from Ecclesia University of Divinity and Azusa Pacific University.

Driven by his commitment to nurturing disciples and preparing students for the work of ministry, Dr. Wilson takes the initiative to create international bible schools, organize conferences, and host seminars to equip leaders for Christian service. He has generously offered his expertise to institutions like Wheaton College, Samford University, Fresno Pacific University, and Warner Pacific University. A globetrotter with a heart for missions, Dr. Wilson enjoys traveling internationally with students, delivering powerful sermons, and teaching the Word of God through various networks, mission agencies, and biblical conferences. He affirms, "There is no greater joy than serving students during this crucial period of their formation journey. Being a guide in their spiritual maturation is a privilege beyond words. I am genuinely honored and thrilled to be part of the Christian family."



### STAN ROSENBERG, Ph.D.

Vice President for Research & Scholarship, CCCU

Stan Rosenberg is the founding director of Scholarship and Christianity in Oxford (SCIO), the UK subsidiary of the CCCU. He is also an academic member of Wycliffe Hall, on the faculty of theology and religion at the University of Oxford, and a fellow of the International Society of Science & Religion. He has published on Augustine's thought, early Christianity and Greco-Roman science, and ancient preaching and popular religion. Rosenberg is on the editorial board of the journal, Religions, and on advisory councils for BioLogos and the Museum of the Bible. He has overseen numerous science and religion projects for faculty funded by

major granting bodies and directs the Logos program on biblical manuscripts, texts, and reception. Recently, he co-organized a funded project that led to his edited book, "Finding Ourselves after Darwin: Conversations on the Image of God, Original Sin, and the Problem of Evil." He holds a B.A. from Colorado State University and an M.A. and Ph.D. from the Catholic University of America.

### RECONSIDERING REQUIRED CHAPEL: EMERGING CONSIDERATIONS FOR A PERSISTENT CONTROVERSY

#### CAMPUS MINISTRY

One way that CCCU institutions across the United States have embodied their commitments to Christian spiritual formation is through chapel. These chapels are as diverse as their campuses, but most CCCU chapel programs share some form of compulsory structure. Required chapel programs may be sturdy fixtures for a university's Christian heritage, yet they demand further theological inquiry to evaluate their influence and implementation. This session will introduce historical and theological arguments for and against required chapel, consider the relevance of required chapel programs in the face of changing institutional realities, and present alternative frameworks for describing university chapel programs beyond a required-optional divide.

#### 2:45 - 3:30 pm THE ASBURY OUTPOURING: SCAFFOLDING A MOVEMENT OF GOD

### STUDENT DEVELOPMENT

The Asbury University team stewarded a spontaneous movement of God, bringing at least 50,000 people to campus over 16 days. With over 56 million TikTok views at the time and "Asbury Revival" as the #1 Google search on Feb. 19, 2023, Wikipedia classifies this event as a phenomenon. What we know is God moved in the heart of Gen Z, and the world watched and showed up in person. A mix of crisis leadership and spiritual discernment unfolded to scaffold what Asbury calls "the Outpouring." While it is too big and too holy to distill into "leadership lessons," giving witness to what God did is shaping for Christian leaders in higher education. Lean into leadership reflections on stewarding a movement of God, crisis management in the midst of structure, and the role of relationship, trust, and imagination as leaders.

#### 4:00 - 4:45 pm ACCOMMODATING PREGNANT AND PARENTING STUDENTS

### STUDENT DEVELOPMENT

Institutions must provide reasonable accommodations for pregnant and parenting students under Title IX and, in some cases, under disability laws. In this session, higher education attorney Kathryn Nash will discuss the legal requirements institutions must follow in providing accommodations for pregnant and parenting students, including any changes released by the Biden administration under the Title IX final rule prior to the conference. If the final rule has not yet been released at this time, this presentation will provide a high-level update on the status of the regulatory timeline. The presentation will also cover the practical steps in the interactive process to identify reasonable accommodations, with Northwest Nazarene University Title IX Coordinator Sheila Bryant sharing her experience working with students, faculty, and administrators to identify and implement accommodations for pregnant and parenting students.

These dynamics impede individual development and threaten democratic education and open discourse, essential for a thriving academic community. Informed by the theological concept of "Imago Dei," which posits that humans are created in the image of God with the capacity for reason and relationship, The Constructive Dialogue Institute provides empirically supported tools grounded in psychology research. Our programming equips students with the requisite skills for conversations that span ideological divides and offers faculty and staff tools to facilitate such dialogues. Through this work, we contribute to both individual and community growth, aligning with the belief that the ability to dialogue effectively is not merely elective but an essential facet of our shared human dignity. In this session, we present three case studies showcasing scalable strategies for integrating dialogue-centered practices and sustaining them throughout the academic year.

The existing process required paper forms that took up significant administrative time and introduced additional questions about equity. However, the new system would have to handle "boutique" questions schools and departments required for accreditation purposes without additional staffing. The implementation was paused for the arrival of a new learning management system (LMS) so it could be integrated using learning tools interoperability (LTI) 1.3. Come to this session to discuss the technical and cultural shifts necessary to implement this new procedure and tool.
